Standing Committee Reports

Fraley, Heinrich and Wolff gave reports on their respective committees.

Legislative Update

Fraley presented a brief overview of Governor Evers budget address as it pertains to local government finance reform. She also spoke about the annual NACO legislative conference.

Interviews for District 8 Vacancy: Karen Gray-Hoehn, Johnny Koremenos, Stacy Kosmatka, Kyle Konieczka, and Neil Palmer

The committee interviewed each of the above-listed candidates to fill the District 8 vacancy on the County Board and submitted ballots to the Chair for consideration.

Discuss and Consider Ordinance 177-O-097 Modify The 2023-2027 Capital Plan And 2023 Capital Budget to Increase Construction Expenditures for Capital Project #202101 – Airport Terminal and Tower Roof Replacement

Waeghe presented that this ordinance would modify the 2023-2027 Capital Plan and 2023 Capital Budget for Capital Project #202101, Airport Terminal and Tower Roof Replacement, to appropriate additional expenditures of \$50,000 and increase Airport Fund balance usage of \$50,000. Bids for this project came in above budget due to the rising costs of petroleum-based materials due to consumer demand and supply limitations.

Discuss and Consider Ordinance 177-O-098 Modify The 2023-2027 Capital Plan And 2023 Capital Budget To Increase Expenditures For Capital Project #202109 - Airport Parking Lot Rehabilitation And Expansion

Stanich presented that this ordinance would modify the 2023-2027 Capital Plan and 2023 Capital Budget for Capital Project #202109, Airport Parking Lot Rehabilitation and Expansion, to appropriate additional expenditures of \$22,100 and increase use of Airport Fund balance by \$22,100. The original construction estimate was lower than the successful bid price. The County's 5% share of the total project cost, after anticipated state and federal revenues are applied, has increased by \$22,100 to \$104,600.

Discuss and Consider Ordinance 177-O-099 Amend Waukesha County Code To Prohibit Use Of E-Cigarettes Anywhere Tobacco Smoking Is Prohibited

Wolff presented that this ordinance amends the Waukesha County Code of Ordinances to prohibit the use of e-cigarettes anywhere that tobacco smoking is prohibited. At the time of previous actions taken by the County and State to ban smoking, e-cigarettes did not exist, and they are presently not expressly included in the County's smoke free environment policy.
