# 1. Call to Order

Chair Revoy called the meeting to order at 8:31 a.m. Introductions were exchanged among the committee members and guests.

#### 2. Review and Approval of Minutes

Motion: Trauth moved, second by Matson, to approve CAFSAC minutes of February 16, 2023. Motion passed without a negative vote.

#### 3. Committee Business

#### a. Critical Needs Update

Revoy displayed and presented a PowerPoint titled "Children and Families Services Advisory Committee DHHS Board Presentation".

Attendees reviewed and discussed the draft Critical Needs PowerPoint for the presentation being held on April 27. Some of the changes and updates included:

- Workforce Challenges slide
  - Acknowledge that it can cause a ripple effect from lack of providers in one area and can affect other areas within the community
  - Access to being licensed professionals is a barrier
  - Lack of staff capacity to help support student interns
- Mental Health Issues slide
  - Update the last line on the slide so that the numbers are reflected correctly
  - Mention that the waitlists for county services can be tied to the workforce challenges from the previous slide
  - Add "CHIPP priority" note (same as the note that is on the Substance Abuse Issues slide)
- Substance Abuse Issues slide
  - Update the "children" wording or add specific ages to be more clear
  - Add additional information on how these issues directly affect families

- Foster Care Shortages slide
  - Change the wording to "Out-of-Home Care Shortages"
- Affordable Housing/Homelessness slide
  - Add statistics from Wisconsin Department of Public Instruction (DPI), if available
  - Investigate and clarify the definition of "youth homelessness" and determine what the specific need is
- During the presentation, point out that truancy could be a consequence of the items discussed in the slides rather than including a specific note within the PowerPoint.
