a. HHS Board Liaison

b. HHS Staff Liaison

Pupp announced that the Juvenile Center will be closing on Friday October 1. Any Waukesha County youth needing to be held in secured detention will be placed in a neighboring county detention facility. Waukesha County is currently contracted with Washington County and is finalizing the contracts with Racine, Rock, and Dane Counties.

There are currently 38 youth enrolled in the Comprehensive Community Services (CCS) program. In order to expand this program, the goal is to hire additional staff in the role of a Service Facilitator with their focus to be strictly on mental health. Each Service Facilitator would have a caseload of about 15 each. The Clinical Division provides CCS services to adults whereas the Adolescent and Family Division provides CCS services to youth. In 2022, the focus will be on the expansion of services for teenagers.

Eve Altizer will be taking over as CCS Coordinator as of September 27.

c. Schools

The School District of Waukesha (SDW) has been awarded the Department of Public Instruction (DPI) school-based mental health provider grant. This grant will help fund the partnership with Family Service to provide a Mental Health Navigator for the eAchieve and LatinX students.

SDW also received United Way grant funds to provide for additional Mental Health Navigators to support the schools.

SDW continues to work through COVID mitigation while also keeping the focus on the students.
