Legislative Update

Spaeth reported that shared revenue will be voted on tomorrow in the Assembly. There has been no action taken by the Senate. Joint Finance Committee approved salary increases for district attorneys across the state. On Thursday, they will be taking up parks and land use items like county conservation grants.

Thelke, Mohr and Gage discussed their report titled "Waukesha Employee Health & Wellness Center Year-End Utilization and Return on Investment Review" which included information on participation,
