Total number of veterans in Waukesha County as of December 31, 2011, per VA figures was 29,025. This does not include the number of dependents of veterans which when added with the veteran population can easily be 60,000 to 70,000 Waukesha County residents.

Veterans have special needs that resulted from their service to their country. Some of these needs are compensation and medical treatment for service-connected disabilities, and help in making adjustments in their lives. They also might need assistance in obtaining an education to enable them to find and maintain gainful employment.

In 2011, there were 7,617 incoming phone calls, 4,102 e-mails and 3,745 client visits to the office. A total of 85 referrals to other federal, state, and county providers for additional services were made during the year. A total of 65 appearances on behalf of veterans were made during the year.


The degree of economic impact that veterans' programs have on our county may be revealed by the following totals of state and federal benefits paid to Waukesha County veterans and their dependents or survivors. The economic impact does not include any multiplier factor when these dollars are used to purchase goods and services in the county time and time again.



VETERANS SERVICE COMMISSION

The amount of expenditures by the Veterans Service Commission in 2011 was \$5,500 for Veterans Relief, and administrative expenditures for the Veterans Service Commissioners were \$1,001. The Commission met three times in 2011. Funding from other Veterans Service Organizations provided an additional \$6,200 in financial assistance.

VETERANS INDIGENT BURIALS

There were no inquiries for Indigent Veteran Burials in 2011.

The Veteran Service Office is a very cost effective operation of county government. The 2011 Budget of \$293,847, which \$280,847 was from the Tax Levy, resulted in a return of \$154,696,692 federal and state dollars to Waukesha County veterans and their dependents. This equates to \$550.82 return for every Levy dollar invested.
