Any costs are paid by the buyer, such as for permits, soil testing or title search. Waukesha County has no documented evidence of the "buildability" of any of the vacant land listed below.

Offers to purchase which involve contingencies should be submitted to the County Treasurer on form WB-13, Vacant Land Offer to Purchase Form. All offers and sales are subject to the approval of the Tax Deed Committee. Properties with appraisals more than three years old may need to be reappraised, at the discretion of the Tax Deed Committee.

Property transfers are recorded by Quit Claim Deed. An additional fee is required for recording the transfer of property. The fee is \$11.00 for the first page and \$2.00 for any additional pages.
