6 WHEREAS the County owns homes that are leased to various social services agencies, and

9 a need for significant repair, and

11 WHEREAS the County Department of Public Works has sought and been awarded a CDBG
12 grant for the purpose of funding repairs to the Century House.

14 THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS
15 that a CDBG grant for the purpose of funding repairs to the Century House in the amount of
16 \$53,000 is accepted on behalf of the County.

18 BE IT FURTHER ORDAINED that the Operating Expenses appropriation unit of the 2001
19 Department of Public Works Building Operations budget be increased by \$53,000 to be offset by
20 \$53,000 of revenues from the Waukesha County Community Development Block Grant
21 program.

FISCAL NOTE

ACCEPT GRANT AND AMEND BUDGET

In a previous action, the Waukesha County Board made an exception to the policy of divesting County-owned rental properties in the case of two houses occupied by certain social services agencies. One of the houses (Century House at 1130 Northview Road) requires major repairs, for which the Department of Public Works applied for Community Development Block Grant (CDBG) funding. The CDBG Board approved \$53,000 in grant funding for that purpose, and this ordinance appropriates that amount to the operating expenses appropriation unit of the 2001 Public Works Building Operations budget. In the event that the current program ceases operations at that location within five years of receipt of the grant, the County will be required to reimburse CDBG on a pro rata basis.

The County will continue to perform routine repairs and maintenance (estimated at \$2,000 to \$3,000 annually) at this property; and will continue to charge rent (\$790/month in 2002).
