

CHANGE NAME OF DEPARTMENT OF AGING  
TO DEPARTMENT OF SENIOR SERVICES

WHEREAS the Commission on Aging has recommended that the name of the Department of Aging be changed to the Department of Senior Services, and

WHEREAS the Department of Aging was created by adoption of County Resolution No. 11 on May 11, 1978 in recognition of the increased emphasis on programs for the elderly, and

WHEREAS Waukesha County Code of Ordinances Sec. 2-90(c)(1) designates the health and human services committee to act as the committee of budget and policy oversight for the department of aging, and

WHEREAS Wisconsin Statute Sec. 46.82 calls for the county board of supervisors to establish a county aging unit to administer programs of services for older individuals of the county, and the Waukesha County Board of Supervisors has designated the Waukesha County Department of Aging as the county aging unit, and

WHEREAS in administering programs of services for older individuals of the county the Department of Aging is a resource center for information concerning a wide spectrum of community services for older individuals, and

WHEREAS the emphasis of the Department of Aging is on services, support and opportunities which promote choice, independence and community involvement for older individuals of the county.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the name of the Department of Aging is changed to Department of Senior Services effective immediately.

BE IT FURTHER ORDAINED that Waukesha County Code of Ordinances Sec. 2-90(c)(1) is repealed and recreated to read:

(c) Duties. The duties of the health and human services committee shall be as follows:

- (1) To act as the committee of budget and policy oversight for the department of senior services, the department of health and human services, the department of veterans' service, the aging commission, the health and human services board, the long term support planning committee, and the veterans' service commission and the Waukesha County Housing Authority.

BE IT FURTHER ORDAINED that the name of the County Aging Unit be changed to the Waukesha County Department of Senior Services.

BE IT FURTHER ORDAINED that the editor of the Waukesha County Code shall, as appropriate and expedient, change all references to the Department of Aging in the Waukesha County Code in conformance with this ordinance.
