APPROPRIATE SUPPLEMENTAL JUVENILE ACCOUNTABILITY BLOCK
GRANT FOR THE DEPARTMENT OF HEALTH AND HUMAN SERVICES

WHEREAS the State Office of Justice Assistance has awarded supplemental JAIBG funds to Waukesha County in the amount of \$15,000, and

WHEREAS the supplemental funding was not anticipated in the 2001 budget, and

WHEREAS the County of Waukesha intends to utilize this one time funding allocation for the purchase and placement of heart defibrillator machines in the City of Waukesha's three public high schools, and

WHEREAS said provision shall be executed under a memorandum of understanding between the County and City of Waukesha detailing the express purpose of the purchase, placement and training in the use of defibrillators to enhance school safety.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the 2001 Adolescent and Family Services Juvenile Services Organization budget be modified by increasing intergovernmental revenues by \$15,000 and by increasing operating expenses by the same amount to cover the cost of the purchase of defibrillators and training in their use.



APPROPRIATE SUPPLEMENTAL JUVENILE ACCOUNTABILITY BLOCK GRANT
FOR THE DEPARTMENT OF HEALTH AND HUMAN SERVICES

This ordinance authorizes the Department of Health and Human Services to accept \$15,000 from the Wisconsin Office of Justice Assistance on behalf of the City of Waukesha for the purchase and placement of heart defibrillator machines in public high schools. The County will provide the City with the grant proceeds, and the City will be responsible for acquiring the equipment and training police school liaison officers in its use.
