

AMEND WAUKESHA COUNTY CODE OF ORDINANCES  
PERTAINING TO CAPITAL PROJECT DEFINITION

WHEREAS current code defining capital projects with amounts usually in excess of \$25,000 was approved in 1988, and

WHEREAS the total capital budget has increased from the 1998 expenditure of \$5.9 million to the 2002 expenditure budget of \$23.2 million, and

WHEREAS it is desirable that County Code reflect current costs and practices.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES  
ORDAIN

SECTION 1. Waukesha County Code of Ordinances, Section 2-410(a) (2) is repealed and recreated to read:

*Capital project* means an active or proposed nonrecurrent expenditure in one or more specified plan years of an amount usually in excess of one hundred thousand dollars (\$100,000.00) for costs associated with a permanent fixed asset (e.g. building, land, highway and technology improvements, equipment) which has a useful life or extends the useful life of an existing fixed asset, usually in excess of seven (7) years.

SECTION 2. This ordinance shall be effective upon approval and publication.


SECTION 3. The provisions of this ordinance shall be included and incorporated in the Code of Ordinances of the County of Waukesha, Wisconsin, as an addition or amendment thereto and shall be appropriately renumbered to conform to the numbering system contained therein.

SECTION 4. Any code section or part of a section in conflict with this ordinance is hereby repealed and declared null and void and of no effect.


