WHEREAS, the Sheriff's Department received this donation in November of 2002 which is reserved in the general fund balance at year end, and

WHEREAS, this donation amount for this proposed expenditure needs to be appropriated in the 2003 Sheriff Budget.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that \$2,500 received in donated funds be appropriated from the reserved general fund balance to increase the Sheriff's Department 2003 expenditure and revenue budget in the appropriate accounts for purchase of replacement canine bailout units for the Department's canine patrol.
