

14 demolition of this structure and restoration of the site.



FISCAL NOTE

AUTHORIZATION TO DISPOSE OF BUILDING

This ordinance authorizes the Department of Public Works and Department of Parks and Land Use to dispose of a structure located at S66 W30330 County Trunk Highway I. The Parks and Land Use 2004 budget includes \$20,000 in operating expense appropriations for the estimated demolition, disposal and site restoration costs. The structure is currently vacant, and no rental revenue is expected or was budgeted for in 2004.
