9 WHEREAS, reemerging and new infectious diseases such as SARS will pose a rising global
10 health threat, and
11

12 WHEREAS, these diseases and new animal zoonotic diseases (e.g., monkey pox and west nile)
13 will endanger US citizens at home and abroad, and

15 WHEREAS, wide spread natural and/or bioterrorism communicable disease outbreaks and other
16 large scale public health events require a regional public health community response, and
17

18 WHEREAS, the State of Wisconsin has allocated available funds for the purpose of establishing
19 effective regional public health consortiums to respond to regional health threats, and
20

21 WHEREAS, the City of Wauwatosa has agreed to act as the lead Administrative Agency and
22 Fiscal Agent for the Consortium, and


24 WHEREAS, the thirteen City Health Departments in Milwaukee County and the Waukesha
25 County Public Health Division will join to form a Consortium for Emergency Public Health to
26 strengthen the competence, capability, coordination and readiness of the regional public health
27 community for a Regional Public Health response when needed.


29 THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS

39 preparedness.


