

ENROLLED ORDINANCE 159-98

ESTABLISHMENT OF SPEED ZONE – CTH I

WHEREAS Wisconsin Statutes permit local authorities to establish speed zones within certain guidelines, and

WHEREAS a traffic engineering study has been made to determine the safe travel speed for all vehicles upon CTH I in the Town of Waukesha and the City of New Berlin.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the speed zone on CTH I is modified as follows:

1. Establish a forty-five (45) miles per hour speed zone on CTH I from its intersection with CTH H easterly to a point 6100 feet west of its intersection with CTH Y.
2. Establish a fifty (50) mile per hour speed zone on CTH I from a point 6100 feet west of its intersection with CTH Y easterly to a point 0.40 miles east of its intersection with CTH Y.

BE IT FURTHER ORDAINED that this declaration rescinds all previous restrictions for the above described portion of the County Trunk Highway System.
