

ENROLLED ORDINANCE 160-101

AUTHORIZE THE WAUKESHA COUNTY U.W. EXTENSION OFFICE TO ENTER INTO A SUBCONTRACTOR AGREEMENT WITH IMPACT ALCOHOL AND OTHER DRUG ABUSE SERVICE, INC. OF MILWAUKEE. TO ESTABLISH A DRUG-FREE COALITION AND TO COORDINATE SERVICES IN THE IMPLEMENTATION OF THE DRUG-FREE COMMUNITIES MENTORING PROJECT WITH WAUKESHA COUNTY AND TO APPROPRIATE ADDITIONAL FUNDING TO THE 2006 BUDGET

WHEREAS IMPACT Alcohol and Other Drug Abuse Service of Milwaukee will assist the Waukesha County University of Wisconsin Extension in designing and implementing an effective and efficient system for on-going environmental scans of alcohol, tobacco and other drug abuse needs and service resources in Waukesha County, and

WHEREAS IMPACT Alcohol and Other Drug Abuse Service of Milwaukee has requested the Waukesha County University of Wisconsin Extension to coordinate services in the implementation of the Drug Free Communities Mentoring Grant project with Waukesha County, and

WHEREAS IMPACT Alcohol and Other Drug Abuse Service of Milwaukee has also requested of the Waukesha County University of Wisconsin Extension to meet with designated individuals from Waukesha County and coordinate focus-group meetings with these representatives and other project staff, and

WHEREAS IMPACT Alcohol and Other Drug Abuse Service of Milwaukee will assist the Waukesha County University of Wisconsin Extension in the development of the Waukesha County Coalition as an inclusive, effective and sustainable community anti-drug coalition, and

WHEREAS IMPACT Alcohol and Other Drug Abuse Service of Milwaukee has awarded a subcontract agreement to the Waukesha County University of Wisconsin Extension office for a project consultant to assist in the establishment of a Drug Free Coalition in Waukesha County with a direct contribution of \$12,500, and

WHEREAS this represents to Waukesha County and Waukesha County University of Wisconsin Extension an opportunity to participate in the 2005-2006 Drug-Free Mentoring Program of the Milwaukee Youth and Family Development Alliance and the Waukesha County Coalition, and

WHEREAS the Waukesha County University of Wisconsin Extension 2006 adopted budget did not include the \$12,500 subcontract agreement award for this purpose and, therefore, it needs to be appropriated in the University of Wisconsin Extension 2006 budget.


THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the Waukesha County University of Wisconsin Extension be authorized to enter into an agreement with the IMPACT Alcohol and Other Drug Abuse Service of Milwaukee and receive an award of \$12,500 to establish a drug-free coalition and to coordinate services in the implementation of the drug-free communities mentoring project with Waukesha County.


