

WHEREAS the County Board of Supervisors of Waukesha County finds that the proper improvement in maintenance of the above County Trunk Highway in the City of New Berlin, Waukesha County from a point that is 724.27 feet south of and 6.22 feet east of the South one-quarter corner of Section 29, Town 6 North, Range 20 East, City of New Berlin, Waukesha County to a point that is 1,375.76 feet north of and 12.84 feet west of the South one-quarter corner of Section 29, Town 6 North, Range 20 East, City of New Berlin, requires certain relocation or changes and the acquisition of certain rights of way as shown on the plat marked "Plat of Right of Way Required for CTH Y, Project I.D. 04-2779(13), S. Racine Avenue CTH Y at W. National Avenue CTH ES Relocation, Waukesha County".




