

ENROLLED ORDINANCE 160-17

DESIGNATE DIRECTOR OF EMERGENCY PREPAREDNESS AS HEAD
OF EMERGENCY GOVERNMENT IN ACCORDANCE WITH
CHAPTER 166 OF THE WISCONSIN STATE STATUTES

WHEREAS in 1991, the County Executive appointed the Emergency Management Coordinator as the County head of emergency government in accordance with Wisconsin State Statute Chapter 166, and

WHEREAS as part of the 2005 adopted budget, the Waukesha County Board of Supervisors created a Department of Emergency Preparedness effective July 1, 2005, and

WHEREAS the Emergency Management Coordinator will be part of the Department of Emergency Preparedness and will report to the Director of Emergency Preparedness, and

WHEREAS the County Executive has determined that the Director of Emergency Preparedness should be appointed as the head of emergency government in accordance with Chapter 166 of the Wisconsin State Statutes.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that effective July 1, 2005, the designation of county head of emergency government be removed from the Emergency Management Coordinator classification and added to the Director of Emergency Preparedness classification.


