3 ESTABLISH SALARY FOR COUNTY BOARD SUPERVISOR

4  
5 WHEREAS the Waukesha County Code of Ordinances states that County Board Supervisors  
6 shall receive salaries as determined by the County Board, and

7  
8 WHEREAS Enrolled Ordinance 151-105, adopted on February 25, 1997, indicated that  
9 prospective salaries for elected officials should be established on a rational basis by  
10 approximating cost-of-living adjustments received by county employees in prior years for  
11 comparable periods, and

12  
13 WHEREAS non-represented employees received across-the-board increases averaging 1.75% in  
14 calendar year 2004 and across-the-board increases averaging 2.75% in 2005, and

15  
16 WHEREAS, comparable to increases for non-represented employees, the salary for County  
17 Board Supervisors should be adjusted by approximately 1.75% in calendar year 2006 and 2.75%  
18 in calendar year 2007.

19  
20 THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES  
21 ORDAIN that the salary for County Board Supervisors shall be as follows:

23 1. Effective the first pay period following the third Tuesday in April 2006, the salary for County  
24 Board Supervisors shall be increased from \$350.81 bi-weekly (\$9,121 annually) to \$356.95  
25 bi-weekly (\$9,281 annually).  
26  
27 2. Effective the first pay period following the third Tuesday in April 2007, the salary for County  
28 Board Supervisors shall be increased from \$356.95 bi-weekly (\$9,281 annually) to \$366.77  
29 bi-weekly (\$9,536 annually).
