

ENROLLED ORDINANCE 161-47

APPROPRIATE STATE OF WISCONSIN DIVISION OF PUBLIC HEALTH  
WOMEN, INFANT AND CHILDREN NUTRITION PROGRAM 2006  
GRANT FUNDING INCREASES TO THE WAUKESHA COUNTY  
DEPARTMENT OF HEALTH AND HUMAN SERVICES

WHEREAS, nutrition related health programs continue among Waukesha County infants, children and pregnant women, and

WHEREAS, the Women, Infant and Children Program (WIC) provides nutritional prescriptions and monetary food vouchers to resolve these current or potential nutrition related health problems, and

WHEREAS, the State of Wisconsin Division of Public Health is providing a net allocation increase to the WIC Grant of \$20,735, bringing the total WIC 2006 grant funding to \$341,912, to offset expenses associated program operations, and

WHEREAS, the 2006 budget for WIC appropriated \$321,177 of anticipated funding, this ordinance seeks to modify the budget by \$20,735 to equal the \$341,912 of state funding.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the Department of Health and Human Services, Division of Public Health be authorized to expend the additional funds allocated for the Women, Infant and Children Program by the State of Wisconsin, Department of Health and Family Services, Division of Public Health.


BE IT FURTHER ORDAINED that the 2006 Department of Health and Human Services, Public Health Division budget be modified by increasing general government revenues by \$20,735 and increasing personnel cost appropriations by \$8,000, operating expense appropriations by \$10,735 and interdepartmental charge appropriations by \$2,000 for Women, Infant and Children Program expenditures.
