

ENROLLED ORDINANCE 161-70

PARKING REGULATION – CTH E

WHEREAS the parking, standing and stopping of vehicles along streets and highways can have a detrimental effect upon capacity and safety, and

WHEREAS Wisconsin Statutes provide that local authorities may regulate the parking, standing and stopping of vehicles along such streets and highways.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the following parking regulation shall be in effect upon the placement of proper signs:

Both sides of CTH E from a point 450 feet North of Wambold Road southerly to a point 450' south of Wambold Road in the Town of Eagle – No Parking Anytime.

BE IT FURTHER ORDAINED that this declaration rescinds all other previous restrictions for the above described roadway.

Ordinance 161-O-066 was presented for action. (Parking Regulation – CTH E)

Supervisor Meyer moved to amend the First Ordained Paragraph by adding lines 13-14 to read:

Both sides of CTH E from a point 450 feet North of Wambold Road southerly to a point 450' south of Wambold Road in the Town of Eagle – No Parking Anytime.

and

Delete lines 16-19.


Supervisor S. Wolff seconded the motion.
