

ENROLLED ORDINANCE 162-113

APPROVE LAND USE PERMIT TO SCHULTZ EXCAVATING FOR THE PURPOSE OF  
CONSTRUCTION, OPERATION, AND MAINTENANCE OF A 6" DRAINAGE

WHEREAS it is necessary to provide a Land Use Permit to allow Schultz Excavating to construct, operate, and maintain a 6 inch drainage pipe within the Waukesha County Bugline Recreation Trail Right-of-Way located in the Village of Lannon, (refer to Exhibit "A"), and

WHEREAS in consideration of said Land Use Permit Schultz Excavating shall pay to Waukesha County the normal Land Use Permit Fee of \$136.00.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Land Use Permit between Schultz Excavating and Waukesha County, on file in the Office of the County Clerk, is hereby approved

BE IT FURTHER ORDAINED that the revenue from the Land Use Permit be deposited in the Walter J. Tarmann Parkland Acquisition Fund.




