MODIFY WAUKESHA COUNTY UNIVERSITY OF WISCONSIN EXTENSION OFFICE  
2008 BUDGET TO APPROPRIATE DONATIONS RECEIVED FROM THE 4-H  
LEADERS' ASSOCIATION AND FUNDING SUPPORT FROM UNIVERSITY  
OF WISCONSIN SYSTEM FOR THE AMERI CORP VISTA PROGRAM

WHEREAS the Waukesha County 4-H Leaders' Association has donated \$10,208 to Waukesha County University of Wisconsin Extension for support of the 4-H Youth Leadership program, and

WHEREAS the County UW-Extension Office received these funds from the Waukesha County 4-H Leaders' Association for the purpose of professional development, and

WHEREAS the Board of Regents of the University of Wisconsin System has provided funding support of \$1,355 in 2007 to Waukesha County University of Wisconsin Extension Office to cover a cost share arrangement for an Ameri Corp Vista Worker, and

WHEREAS the Waukesha County UW-Extension Office received these funds in prior years, and did not appropriate this funding in their past or current budgets therefore, these funds lapsed to the general fund balance and need to be appropriated in order to accomplish the funding purpose.

THE COUNTY BOARD OF SUPERVISORS DOES ORDAIN that the Waukesha County University of Wisconsin-Extension Office is authorized to appropriate \$11,563 of funding received from the Waukesha County 4-H Leaders' Association and the University of Wisconsin System.


