WHEREAS the Village of Sussex and Waukesha County have come to agreement on the terms of the payment of said capital contribution and use of the facility, and

WHEREAS the 2008 budget requires that the final agreement for payment of the money to the Village will be brought back before the County Board for approval, and


WHEREAS it is anticipated that the Village of Sussex and Waukesha County Sheriff's Department will have a lengthy, positive relationship.


