

ENROLLED RESOLUTION 162-17

AMEND THE REGIONAL WATER QUALITY MANAGEMENT PLAN FOR THE  
CITY OF BROOKFIELD, WAUKESHA COUNTY, WISCONSIN

WHEREAS the Southeastern Wisconsin Regional Planning Commission, duly created by the Governor of the State of Wisconsin in accordance with Section 66.945(2) of the Wisconsin Statutes on August 8, 1960, upon the petition of the Counties of Kenosha, Milwaukee, Ozaukee, Racine, Walworth, Washington and Waukesha, has the function and duty of making and adopting a Master Plan for the physical development of the region, and

WHEREAS the Southeastern Wisconsin Regional Planning Commission prepared and adopted on July 12, 1979, a report entitled "Regional Water Quality Management Plan for Southeastern Wisconsin-Year 2000", (Southeastern Wisconsin Regional Planning Commission Report No. 30), and

WHEREAS the Waukesha County Board of Supervisors has supported, participated in the financing of, and generally concurred in the Regional Planning Programs undertaken by the Southeastern Wisconsin Regional Planning Commission and believes that the Regional Water Quality Management Plan for the Southeastern Wisconsin Region is a sound and valuable guide providing technical data and support to the concept of further refinement of the adopted Regional Land Use Plan, and

WHEREAS the County Board of Supervisors has adopted the "Regional Water Quality Management Plan for Southeastern Wisconsin – Year 2000", Planning Report No. 30 on October 23, 1979 in Resolution No. 140, and

WHEREAS the City of Brookfield requested on December 21, 2006, an amendment to Community Assistance Planning Report No. 109, to annex certain lands in the City of Brookfield (Fox River Pollution Control System) /Village of Elm Grove (MMSD) Sanitary Sewer Service areas, and after due notice and public hearing held on February 13, 2007, and preparation of a report entitled "Amendment to the Regional Water Quality Management Plan for the City of Brookfield, Waukesha County, Wisconsin", dated March 2007, said amendment was adopted by the Southeastern Wisconsin Regional Planning Commission on March 7, 2007, and by the City of Brookfield Common Council on February 20, 2007, and




