

ENROLLED ORDINANCE 163-4

ACCEPT HOMELAND SECURITY-URBAN AREA SECURITY INITIATIVE FY2007
PROGRAM FUNDING AND MODIFY THE EMERGENCY PREPAREDNESS
2008 BUDGET TO APPROPRIATE GRANT REVENUES AND
EXPENDITURES FOR A MOBILE COMMAND POST

WHEREAS, the United States Department of Homeland Security designated Waukesha County, along with the City of Milwaukee, Milwaukee, Ozaukee, Racine and Washington Counties as an Urban Area eligible for grant funding to enhance the capabilities to prevent, respond to, and recover from acts of terrorism, and

WHEREAS, federal fiscal year 2007 Homeland Security-Urban Area Security Initiative (UASI) grant funding is available to the Urban Area agencies, and

WHEREAS, the Milwaukee UASI included a funding request for Waukesha County to purchase a mobile command post to assist with response coordination of multiple agencies, disciplines and jurisdictions during emergencies, and

WHEREAS, the mobile command post will include state of the art technology to support and coordinate on-scene activities during significant emergencies, and

WHEREAS, Waukesha County and the State of Wisconsin have developed a Memorandum of Understanding, which is on file with the Office of Emergency Management, that indicates that should there be an emergency outside the County, the State could request to use this equipment, and

WHEREAS, the United States Department of Homeland Security and the Wisconsin Office of Justice Assistance approved the investment justifications, allocated funding and authorized Waukesha County to submit a grant application this mobile command post.


THE COUNTY BOARD OF SUPERVISORS OF WAUKESHA COUNTY DOES ORDAIN that the Waukesha County Emergency Preparedness Department-Emergency Management Office be authorized to accept \$450,000 of Federal Homeland Security grant funding.


