WHEREAS, a review of some position classifications has shown that reclassifications are appropriate, and

WHEREAS, a title change of a classification is appropriate.


THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN as follows:


- I The regular full-time and regular part-time positions, as listed in the attached Table I will be created or abolished as identified in Table I, effective January 3, 2009.
- II The reclassifications as listed in Table II will be accomplished effective January 3, 2009.
- III The title of the Senior Park Naturalist classification shall be changed to Conservation Biologist, effective January 3, 2009.
- IV The classification specifications for Registered Dietetic Technician and the Records Management Analyst, on file in the County Clerk's office and the Division of Human Resources in the Department of Administration, are adopted effective January 3, 2009.


