

ENROLLED ORDINANCE 163-71

RELEASE OF LIMITED EASEMENT FOR SOIL TESTING  
TOWN OF MERTON, WAUKESHA COUNTY

WHEREAS, in 1983 the County acquired a limited easement for soil testing on land located at N55 W28133 County Trunk Highway K in the Town of Merton which allowed the County access to the land to investigate its suitability as a landfill site, and

WHEREAS, the County has never exercised its rights under this easement and no longer has plans to develop a landfill at this location, and

WHEREAS the current owner of the property wishes to sell the property and the buyer has approached the County with a request for the County to release the limited easement for soil testing.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the limited easement for soil testing on property located in the Town of Merton, recorded as Reel 548, Image 077, Document 1216926 in the Office of the Register of Deeds for Waukesha County shall be released.

BE IT FURTHER ORDAINED that the Corporation Counsel and the Director of the Department of Parks and Land Use shall review or prepare the documents necessary to release the easement granted to the County, and the Director of the Department of Parks and Land Use is further authorized to execute said documents on behalf of the County and ensure that the landowner or buyer records the documents with the Waukesha County Register of Deeds.


