

ENROLLED ORDINANCE 163-77

REPEAL AND RECREATE SECTION 4-110(c) 1 TO MAKE UPDATES
RELATING TO THE AGING AND DISABILITY RESOURCE CENTER

WHEREAS, Waukesha County created an Aging and Disability Resource Center which required certain changes to be made to the County Code to remove references to departments and commissions rendered obsolete by the creation of the new County department, and

WHEREAS, necessary changes to section 4-110 of the County Code were inadvertently not made.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that:

SECTION 1. Section 4-110(c) 1 of the Waukesha County Code of Ordinances is repealed and recreated to read as follows:

1. To act as the committee of budget and policy oversight for the Aging and Disability Resource Center, the department of health and human services, the department of veterans' services, the Aging and Disability Resource Center Advisory Board, the health and human services board, the long term support planning committee, the veterans' service commission and the Waukesha County Housing Authority.

SECTION 2. This ordinance shall be effective upon approval and publication.


SECTION 3. The provisions of this ordinance shall be included and incorporated in the Code of Ordinances of the County of Waukesha, Wisconsin, as an addition or amendment thereto and shall be appropriately renumbered to conform to the numbering system contained therein.

SECTION 4. Any code section or part of a section in conflict with this ordinance is hereby repealed and declared null and void and of no effect.


