APPROVE LAND USE PERMIT TO VILLAGE OF SUSSEX TO CONSTRUCT, OPERATE

WHEREAS the land use permit and supporting documentation and diagrams are on file in the offices of the Department of Parks and Land Use and the Waukesha County Clerk, and


WHEREAS the Village of Sussex has agreed to improve the Bugline Trail and Highway VV crossing, and


