ESTABLISH SALARIES FOR ELECTED OFFICIALS WHOSE
FOUR-YEAR TERMS WILL COMMENCE IN 2009

WHEREAS the Waukesha County Code of Ordinances directs the County Board to propose changes in compensation and benefits for all elected officials, and

WHEREAS salaries for the County Clerk, Register of Deeds, and Treasurer must be set prior to candidates beginning the election process.


THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES
ORDAIN that the annual salaries of the County Clerk, Register of Deeds, and Treasurer shall be:


1. Effective the first pay period commencing in 2009 through 2010 as follows: County Clerk - \$67,116; Register of Deeds - \$68,020 and Treasurer - \$67,116
2. Effective the first pay period commencing in 2011 as follows: County Clerk - \$67,787 Register of Deeds - \$68,700; and Treasurer – \$67,787
3. Effective the first pay period commencing in 2012 as follows: County Clerk - \$69,143; Register of Deeds - \$70,074; and Treasurer - \$69,143


