

ENROLLED ORDINANCE 164-50

ESTABLISH VOLUNTARY JUROR DONATION PROGRAM

WHEREAS, Section 756.25, Wisconsin Statutes, requires the payment of juror fees and travel expenses to and from the court, and

WHEREAS jurors often request an option to donate or forego payment of said jury fees for any number of reasons, and

WHEREAS, the Clerk of Circuit Court wants to make a Voluntary Jury Donation Program available to jurors allowing them to voluntarily donate payment of said jury fees for Jury Program improvement projects, and

WHEREAS, the County donated funds policy provides that funds received for a special project from a number of donors and over an extended period of time may justify a special account or fund, and

WHEREAS, approval of the donation program also requires the creation of a fund which shall be used only for purposes of providing direct financial support for special Jury Program improvement.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that a Voluntary Juror Donation Program shall be created which will allow those persons receiving jury pay and travel compensation to donate money paid directly back to the Waukesha County Circuit Courts Jury Program for improvements to the Jury Program as recommended by the Clerk of Circuit Court.
