

Amendment to Ordinance 165-O-011

Supervisor Rolfs moved to amend Ordinance 165-O-011 as follows:

On lines 24 through 27 delete the salary figures for the Clerk of Courts which reflects a 1% increase in 2011 and 2% increases in each year 2012 through 2014 and replace with the following salary figures reflecting a 1% increase in 2011 and 2012 and a one and one-half percent (1 ½) in each year 2013 and 2014: a.2011 \$73,963; b. 2012 \$74,703; c. 2013 \$75,823; 2014 \$76,961.

On lines 32 through 35 delete the salary figures for the Sheriff which reflect a 1% increase in 2011 and 2% increases in each year 2012 and 2014 and replace with the following salary figures reflecting a 1% increase in 2011 and 2012 and a one and one-half percent (1 ½) in each year 2012 and 2014: a. 2011 \$97,829; b. 2012 \$98,807; c. 2013 \$100,289; 2014 \$101,794.

On lines 40 through 43 delete the salary figures for the County Executive which reflects a 1% increase in 2011 and 2% increases in each year 2012 through 2014 and replace with the following salary figures reflecting a 1% increase in 2011 and a one and one-half percent (1 ½) in each year 2012 through 2014: a.2011 \$98,052; b.2012 \$99,253; c.2013 \$101,016; 2014 \$102,531.

With the adoption of this amendment, the four-year fiscal impact of the ordinance is reduced from \$21,092 to \$14,979.

Supervisor Falstad seconded the motion.

The amendment was adopted 17-6.

The ordinance was adopted as amended 20-3.

ENROLLED ORDINANCE 165-2

ESTABLISH SALARIES FOR SHERIFF, CLERK OF COURTS,
AND COUNTY EXECUTIVE FOR 2011-2014

WHEREAS, the Waukesha County Code of Ordinances states that the Clerk of Courts, County Executive, and Sheriff shall receive salaries as determined by the County Boards, and

WHEREAS, the next four year term of office for the Clerk of Courts, County Executive, and Sheriff will begin in 2011, and

WHEREAS, it is advisable to establish the salaries prior to the time period when nomination papers are circulated, and

WHEREAS, in 2007 the County Board adopted a policy that all newly hired non-represented employees would contribute one percent (1%) of their wages toward the employee's share of the pension.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the annual salaries of the Clerk of Courts, County Executive, and Sheriff shall be:

I. The annual salary for the Clerk of Courts shall be modified effective the first pay period of the calendar year as follows:

a. 2011	\$73,963
b. 2012	\$74,703
c. 2013	\$75,823
d. 2014	\$76,961

II. The annual salary for the Sheriff shall be modified effective the first pay period of the calendar year as follows:

a. 2011	\$97,829
b. 2012	\$98,807
c. 2013	\$100,289
d. 2014	\$101,794

III. The annual salary for the County Executive will be effective the first pay period following the 3rd Tuesday in April of the following calendar years:

a. 2011	\$98,052
b. 2012	\$99,253
c. 2013	\$101,016
d. 2014	\$102,531

BE IT FURTHER ORDAINED that effective in 2011 with the first salary increase provided for by this ordinance, the County Executive, Sheriff, and Clerk of Courts will contribute one percent (1%) of their wages toward the employee's share of Wisconsin Retirement System.
