

ENROLLED ORDINANCE 165-75

AUTHORIZE THE WAUKESHA COUNTY SHERIFF'S DEPARTMENT TO AMEND
THE EXISTING CONTRACT FOR POLICE SERVICES WITH THE
VILLAGE OF SUSSEX AND THE VILLAGE OF MERTON

WHEREAS, the Village of Sussex Board approved their 2011 village budget with expenditure authority to expand the existing five year contract to increase the one five day a week patrol shift added in 2010 to one seven day a week patrol shift, and

WHEREAS, the Village of Merton requested the Village of Sussex Board to share the dedicated Sussex lieutenant position with the Village of Merton so that the Village of Merton could receive and pay for two hours a week of Sussex lieutenant coverage, and

WHEREAS, the Village Boards requested the Waukesha County Sheriff's Department to develop contract addendums to reflect the additional two days a week of deputy coverage for the Village of Sussex and the shared lieutenant position between the Village of Sussex and the Village of Merton, and

WHEREAS, the 2011 Waukesha County Sheriff's Budget and the 2011 Position Ordinance was developed reflecting the additional revenue associated with the Village of Sussex contract expansion and the additional position associated with the contract expansion, and

WHEREAS, the sharing of the Sussex lieutenant position between the two communities is essentially revenue neutral for the Waukesha County Sheriff's Department.


THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the contract for services on file with the Waukesha County Sheriff which sets forth the agreement for the Waukesha County Sheriff's Department to provide police services to the Village of Sussex be amended to include the increase of the one five day a week patrol shift to one seven day a week patrol shift.



FISCAL NOTE

**AUTHORIZE THE WAUKESHA COUNTY SHERIFF'S DEPARTMENT TO AMEND
THE EXISTING CONTRACT FOR POLICE SERVICES WITH THE VILLAGE OF
SUSSEX AND THE VILLAGE OF MERTON**

This ordinance authorizes the Waukesha County Sheriff's department to amend it's contract for police services with the Village of Sussex to include an increase from one five day a week patrol shift to one seven day a week patrol shift. The ordinance also modifies the contract to allocate two hours a week of the Sussex lieutenant time to supervisory duties in support of the Village of Merton.

The impact of these changes (approximately \$53,700) was planned for and included in the 2011 Sheriff's Department Adopted Budget.
