

ENROLLED ORDINANCE 166-16

ALLOW FOR STATUTORILY AUTHORIZED GOOD TIME CREDIT FOR
HUBER DETAINEES PERFORMING COMMUNITY SERVICE WORK

WHEREAS, Wisconsin Statutes allow certain Huber detainees to perform community service work while serving their sentence at the Huber facility and local non-profit agencies take advantage of this program, and

WHEREAS, Waukesha County through the Department of Parks and Land Use and the Department of Public Works has created a program to utilize Huber prisoners to perform certain community service work, and


WHEREAS, Wisconsin Statute 973.03(3)(am), allows for a county board to provide for increased good time credit under certain conditions for community service work provided by Huber detainees which may enhance the number of inmates volunteering for the program, and


WHEREAS, it is anticipated that allowing for the faster earning of good time could, for certain prisoners under appropriate circumstances, result in an overall reduction in total number of jail days.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that when a defendant sentenced to a Huber facility performs community service work, the defendant may earn one day of good time for each 8 hours work performed as authorized by Wisconsin Statute 973.03(3)(am).






