ACCEPT JOINT FEDERAL JUSTICE ASSISTANCE GRANT AND MODIFY
WAUKESHA COUNTY SHERIFF DEPARTMENT'S 2012 BUDGET
TO AUTHORIZE GRANT EXPENDITURES

WHEREAS, the Federal Edward Byrne Justice Assistance Grant program (JAG) made grant funds available to the Waukesha County Sheriff's Department in partnership with the City of Waukesha Police Department, and

WHEREAS, these grant funds became available after the 2012 budget process was completed, and

WHEREAS, the Sheriff's Department has identified uses for this funding for additional equipment to enhance law enforcement operations.



FISCAL NOTE


ACCEPT JOINT FEDERAL JUSTICE ASSISTANCE GRANT AND
MODIFY WAUKESHA COUNTY SHERIFF DEPARTMENT'S 2012
BUDGET TO AUTHORIZE GRANT EXPENDITURES

This ordinance authorizes the Sheriff's Department to appropriate \$6,236 of Edward Byrne Justice Assistance grant award funds in partnership with the City of Waukesha Police Department to the 2012 Budget for the Sheriff. The City will act as the fiscal agent and will provide the funds as a condition of receiving a City of Waukesha grant award. These federal funds will be used for additional safety equipment to enhance law enforcement operations. No County indirect costs are covered by this grant funding.

The Department's cost estimates related to this ordinance are as follows:

Ammunition Supplies	\$1,056
Child Finger Print Kits	\$900
Total Costs	\$6,236

This ordinance results in no additional direct levy impact.
