Retzer Nature Center is holding a large, family oriented festival on Saturday, September 20, 2014. We expect over 4,000 people to attend this event, which will have a nature and agricultural heritage theme. In addition to the arts and crafts fair, there will be nature walks through prairie and orchard, apple cider, apple pie judging, nature games for children, and a musical performance. There will also be an auction to raise money for the nature center. An extensive publicity campaign is planned for the day.

The arts and crafts fair will have a natural and/or heritage theme. All items must be original work. Kits are not permitted. All exhibitors must meet two of the following criteria:

1. Theme or subject matter of the artwork or craft item must be nature/wildlife related;
2. Materials used must be natural materials (natural dyes, wood, clay, etc.);
3. Craft must utilize or reflect skills of our pioneer or Native American heritage (blacksmith, woodwright, spinner, etc.).

We prefer to accept exhibitors who

- have done the work they are exhibiting themselves, rather than exhibiting the work of others;
- are using original ingredients and components that they have found or made themselves, rather than using purchased ingredients;

- have items with a fresh, original, or uncommercial look, rather than a commercial look;
- do a particular art or craft, rather than “full service crafters” with many different kinds of items.

DISPLAY SPACE

Each exhibitor receives one 12' x 12' outdoor exhibitor space. These may be on grass or on pavement, at the nature center's discretion. Exhibitors need to come prepared to set up on either surface. Chair(s) and 8' foot table(s) are available for rental. See application form. Rain and wind protection for the space and its contents is the personal responsibility of each exhibitor. One space allowed per exhibitor.

SCHEDULE

1. Set-up time is from 7:00 a.m. to 9:00 a.m.
2. Exhibit time is 9:00 a.m. to 5:00 p.m. Exhibitors are expected to be open for sales during this entire time.

APPLICATION FEES AND DEMONSTRATORS

1. All applications must be received by September 1.
2. Applications must be accompanied by 3-5 photographs, slides, or jpeg computer file showing the artist's/craftsman's work. Include your name on each photo or slide. Photos and slides will be returned. You can e-mail your photo's or jpeg file to us at retzer@waukeshacounty.gov
3. Because this is an educational as well as social event, we encourage exhibitors to demonstrate their art/craft at their booth. A \$50 exhibitor fee is required with the application for those who do not demonstrate their craft. A reduced fee of \$25 is required with the application for exhibitors who agree to demonstrate their craft throughout the day.*
*** Note that to qualify for the reduced fee, demonstration must show substantial creation of the art work or craft work, in an educational context. Please indicate what your demonstration will consist of on the reserve side of the application form.**
4. Electricity is not available to exhibitors.
5. You will be notified of your acceptance or your fee will be refunded by September 7.

AUCTION

The Friends of Retzer Nature Center will hold a fundraising auction during the day. Exhibitors who donate a sample of their work to the auction will receive good publicity coverage, including a mention of name and business location when the item is auctioned. Please indicate on your application if you would be willing to donate an item.
