Chairman's Report.

Chairman Crowley informed the commission that the airport's annual report was presented at the County Board meeting. Both Chairman Crowley and Kurt Stanich, Airport Manager were present during the presentation.

Presentation of Wisconsin 128th Air Refueling Wing Mid-Air Collision Avoidance Guide (MACA).

Presented by SMSgt. Scott Zane from the 128th Air Refueling Wing. Pamphlet will be disturbed to surrounding airports by the 128th.

Operations Report.

Fuel Farm Flowage: Jet A fuel sales decreased by 1.97% in August 2020 compared to August 2019. 100LL sales were up 6.25% from August last year.

Tower Operations: Total Traffic increased by 0.53% compared to August last year. General Aviation increased by 2.4%, Air Taxi decreased by 25.4% and there were 20 military aircraft compared to 43 in August 2019.

Regional airports comparison for January - July 2020 shows Waukesha ahead with Janesville and Waukegan trailing closely behind for General Aviation operations.

Operations Supervisor Aimee Scrima is preparing the airport for snow season. Congratulations to her on her first solo.

Manager's Report.

Airport staff are currently working on improvements to emergency response at the airport. Airtoberfest has been cancelled due to COVID-19 restrictions. "Stein's for Scouting" will take place Oct 3rd. More information to be found in airport newsletter and social media. Food truck Friday ended with a successful season.
