Minutes of the Land Use, Parks & Environment Committee Tuesday, February 20, 2024

Supervisor Foti called the meeting to order at 8:30 a.m.

Discuss and Consider Ordinance 178-O-086 Modify The 2024 Workforce And Economic Development Fund Budget To Accept The Employ Milwaukee Skills To Build Grant And Appropriate Expenditures Shaver presented that this ordinance modifies the 2024 Parks and Land Use - Workforce and Economic Development Fund budget, accept the Employ Milwaukee Skills to Build grant of \$1,518,349 and authorizes expenditure authority of \$1,366,514. The remaining \$151,835 of grant funds are reimbursement for estimated indirect costs at 10% of the total grant, which is already included in the budget and does not require additional appropriation.

Discuss and Consider Ordinance 178-O-087 Approve Town Of Genesee Ordinance No. 23-5 Which Amends The District Zoning Map Of The Town Of Genesee Zoning Code By Conditionally Rezoning Certain Lands Located In Part Of The SE ¼ Of Section 34, T6N, R18E, Town Of Genesee, Waukesha County, Wisconsin, From The A-2 Rural Home District To The A-3 Suburban Estate District (RZ136) Fruth presented that this ordinance approves the Town of Genesee Ordinance 23-5 which rezones property located on the southwest corner of STH 83 and Fields Crossing Drive in the Town of Genesee from the A-2 Rural Home District to the A-3 Suburban Estate District to allow for creation of a single family lot.

Discuss and Consider Ordinance 178-O-088 Approve Town Of Genesee Ordinance No. 23-6 Which Amends The District Zoning Map Of The Town Of Genesee Zoning Code By Rezoning Certain Lands Located In Part Of The NW ¼ Of Section 27, T6N, R18E, Town Of Genesee, Waukesha County, Wisconsin, From The B-2 Local Business District To The B-3 General Business District (RZ137) Fruth presented that this ordinance will approve Town of Genesee Ordinance No. 23-6 which rezones property located on Commercial Drive in the Town of Genesee from the B-2 Local Business District to the B-3 General Business District to allow an automotive sales and service repair business.

Fraley also reported that the county is looking into various resources, including pursuit of congressional directed spending, to help with the deficit in the Moorland Road project.
