Comprehensive Community Services (CCS)

Altizer announced that the CCS Youth Unit has compiled the completed annual satisfaction survey results into a user-friendly PowerPoint. 82 families were qualified to take the survey and received the survey, 59.76% were returned.

CCS staff presented at Waukesha West High School regarding mental and behavioral health careers.

Yauchler commented that, as the youth program has expanded so quick, there has been an impact on the adult program – which is at capacity. Staff are currently looking to gather data on the youth that are transitioning to adulthood and maintaining Medicaid eligibility.

Attendees expressed an interest in including a request for CCS program staffing to be included on the annual Community Needs presentation.
