5. Committee and Organizational Updates

a. HHS Board Liaison

There is no HHS Board report.

b. HHS Staff Liaison

Kettler shared that a Crisis Stabilization Therapist, LaShunn Qaasim, has been hired and will be focused on people in mental health crisis as well as keeping people with high needs out of crisis. HHS is seeking case managers to assist LaShunn. Referrals can be made through the County's Mobile Crisis Response Team. Warm referrals are preferred so the client is not surprised when Qaasim or a case manager calls.

WHARP has approximately 40 cases already and more referrals are underway.

The County now has the ability to fund recovery housing and has expanded the continuum of care. Recovery housing is available for individuals in treatment, with a treatment plan (not necessarily through Waukesha County). Lopez confirmed that access to treatment through other facilities has worked but it is more difficult to coordinate than doing in-house care.

Yauchler added that the Crisis Team, currently located in the Human Services Center, will be relocated to the Mental Health Center (MHC) once the remodel is completed. This would place all 24-hour staff under one roof and will increase the synergy between MHC staff and the Crisis Team.

c. Community Health Improvement Planning Process (CHIPP)

Yauchler shared that the final meeting for the current 5-year CHIPP cycle has wrapped up. The most recent cycle focused on suicide prevention, mental health, nutrition and physical activity, and the opioid epidemic.

The Heroin Task Force has begun meeting again. The Steering Committee and Design Team are currently preparing for the full Community Gathering on December 7. The subcommittees have been restructured into action teams focused on Prevention, Harm Reduction, Treatment & Recovery, and Data & Reporting. The action teams have already begun meeting to review ideas generated at the June summit and to create initiatives.
