Minutes of the Joint Meeting of Finance Committee and Health and Human Services Committee Thursday, October 19, 2023

Discuss and Consider the 2024 Department of Health and Human Services Operating Budget
Aldred and Roberts gave a PowerPoint presentation and discussed the proposed 2024 budget for the Health & Human Services Department as outlined in the budget book including functional area budget highlights. Total all funds, department-wide, revenues total \$73,010,927 - an increase of \$1,749,059 or 2% from the adopted 2023 budget. The County tax levy totals \$28,086,647 - an increase of \$952,273 or 4%. Expenditures total \$102,388,643 - an increase of 3,707,958 or 4%. The total number of FTE positions decreases 5.07 for a total of 461.54. Staff reviewed each division as outlined. No major concerns were voiced.
