5. Committee and Organizational Updates

a. HHS Board Liaison

There was no HHS Board report.

b. HHS Staff Liaisons

Waukesha County / HHS

Kettler reported that Waukesha County has released an opportunity for substance use agencies to apply for supplemental funding for substance use prevention. Four organizations will receive \$40,000 each.

Several EMS and law enforcement agencies are now carrying small Naloxone kits that can be left behind with families of overdose victims, should they be needed in the future.

The Crisis Resource Center is now looking at being operational by January 22.

A new Peer Specialist started at the Outpatient Clinic today.

Phase 1 of the jail's medication-assisted treatment (MAT) program has been successful, averaging 18-19 defendants per day. 100% of those coming in on MAT are kept on it, provided that the dose is verified. Phase 1, induction of MAT in the jail, will likely occur in 2025.

Comprehensive Community Services (CCS) / Coordinated Services Team (CST)

Altizer reported that the CCS/CST program served 129 youth in 2023; the goal was to serve 150 youth.

The State's CCS satisfaction survey has been completed.

The next CST meeting will be on January 24.

The adult and youth CCS leadership teams are focusing on how to transition youth into the adult program to maintain their best success.

A full time Outreach Senior Mental Health Counselor has been hired and will be offering referral management at the Mental Health Center for the Community Services Program (CSP), Targeted Case Management (TCM) and CCS. This is in addition to the units' group therapy, TILA medication management, and the significant expansion of the vendor relations network.

c. Peer Specialists of Waukesha County

There was no Peer Specialists of Waukesha County report.

6. Agency Updates / Announcements

Just reported that Addiction Resource Council (ARC) will be placing two more Narcan automated dispensing machines in the community – one machine in Rogers in Oconomowoc, and one at Froedtert Menomonee Falls Hospital. Rogers has also requested the machines be installed at all Rogers' facilities.

By mid to end of 2024, ARC will be offering cards for law enforcement to distribute with a QR code that will direct the user to an app called "We Heart You." The app will provide various community resources, as well as provide a person, 24/7, for the user to talk to.
