Parks and Land Use Funds Transfer requests: Overview given by Fraley and then passed around to committee.

Legislative Update:

Fraley was in Madison over the last few weeks and met with the Chiefs of Staff for both Assembly and Senate leadership.

- Committee assignments are expected later this month. Once all the details are released, she will present an overview to the Board.
- Fraley will be meeting with all the legislators that represent part of Waukesha County in January

- There seems to be an appetite for and recognition of the need for local government funding reform. WCA, League of Municipalities and the WI Towns Association are working with Senate and Assembly leadership as well as the Governor's office on a proposal. The Board will be kept informed as details emerge.
- Senator Darling retired as of December 1. There will be a primary in February and a general election for this seat in April, coinciding with the spring election cycle.

Discuss and Consider Ordinance 177-O-075 Authorize the Execution of Revolving Loan Fund Contribution Agreement Between Waukesha County and the Waukesha County Center for Growth Shaver presented that this is an agreement between the County and the Center for Growth for distribution of funds for businesses looking to grow in or relocate to Waukesha County, obtain business consulting or access to capital for business and job growth.

Discuss and Consider Ordinance 177-O-076 Acceptance of Ice Arena Operational Plan Relating to Original Construction Loans

Shaver and Mattano were present to discuss this item. Shaver presented on the ordinance for the acceptance of the Ice Arena operational plan, which includes the resolution of the Ice Arena debt. The plan will defer the General Fund loan until use levels and revenue recovery declines; waive loan from the Golf Fund; continue to allocate funds for routine maintenance and repair in the annual budget; and fund Capital projects from Waukesha County Parkland Management and Land Acquisition Funds.

Discuss and Consider Ordinance 177-O-074 Approve Easement to the Village of Lannon to Construct, Install, Operate, Maintain, Repair, and Replace Sanitary Sewer and Water Facilities on Waukesha County Property Known as the Bugline Recreation Trail

Mattano presented on the ordinance to grant a sanitary sewer and water main utility easement to the Village of Lannon.

MOTION: Grant moved, second by Howard to approve Ordinance 177-O-074. Motion carried 7-0
