1. Call to Order

Yauchler stated that the Crisis Facility has been up and running for a few weeks. The census is currently being limited to approximately 5 clients due to staffing and other logistics, but staff hope to increase that to the full capacity of 14 by the end of the month. The facility is still operating under a conditional license while facilities complete a few tasks.

Crisis and court monitoring staff are scheduled to relocate to the Mental Health Center in early April.

The outpatient clinic and crisis program had their biannual DHS Division of Quality Assurance survey a few weeks ago and did not receive any citations.

Comprehensive Community Services (CCS)

As of this coming Monday, the adult CCS program will be fully staffed, with a new outreach staff member and a new TILA team member having been hired.

A new vendor, Trainers Royale, is launching with the CCS program.

Coordinated Services Team (CST)

There was no CST Report.

c. Peer Specialists of Waukesha County

Austin reported that there are now two Peer Specialists at Waukesha County, and three Peer Specialists at the Department of Corrections.
