The meeting was called to order at 8:31 a.m.

INTRODUCTION OF GUESTS AND COMMITTEE MEMBERS

Committee members and guests introduced themselves.

APPROVAL OF MINUTES

Minutes from the December 8, 2016 meeting were reviewed. Due to a lack of quorum, the minutes were not approved.

2016 WISCONSIN EPIDEMIOLOGICAL PROFILE ON ALCOHOL AND OTHER SUBSTANCE ABUSE

Muchka presented An Overview of Waukesha County's OWI Trends in Substance Use. Statistics show the majority (58%) of alcohol-attributed deaths were from acute causes such as motor-vehicle crashes, falls and poisonings. In 2015, 40% of recreational vehicle deaths in Wisconsin were alcohol related. Alcohol use among Wisconsin high school students is slightly lower than the national average, while alcohol use among adults is slightly above the national average. The Wisconsin Department of Health Services, Division of Public Health examined trends in alcohol use among adults by age, sex and race. Their findings showed alcohol is consumed mostly by white males between the ages of 25-44. They also examined binge-drinking trends among adults by age, sex and race and found the highest level of binge drinkers are Hispanic males between the ages of 18-24. Of note is the decline of binge drinking in those adults 65 and older. From 2003-2012, Wisconsin has remained moderately above the per capita alcohol consumption of standard drinks for those ages 14 and older. Wisconsin also rates moderately above the national average of women who consume alcohol between the ages of 18-14 and of women who binge drink in the same age group.

PRAMS, the Pregnancy Risk Assessment Monitoring System, is a surveillance project of the Centers for Disease Control and Prevention (CDC) that surveys new mothers. Results from the survey of women who have recently given birth indicate that Wisconsin women are more likely to drink both before conception and during the last 3 months of pregnancy. In 2011, (the most recent year for which there is comparable national data) 67% of new mothers in Wisconsin consumed alcohol in the 3 months before they became pregnant, which is 10% higher than the average for all states participating in PRAMS.

Also surveyed were Wisconsin high school students and the use of illicit drugs (marijuana, prescription drugs without a valid prescription, inhalants, cocaine). When comparing Wisconsin high school students to the national average of high school students, Wisconsin high school student use was

slightly below the national average. Those age groups with the highest percent of use fell within those aged 18-25.

In Waukesha County, 777 liquor licenses were issued for the period beginning July 1, 2014 and expiring July 1, 2015. Of those issued, 216 were Class A licenses and 559 were class B licenses. This amounts to 1 liquor license per 500 people in Waukesha County's 2014 population of 392,761.

Trending of late is a drug called U47700 (U4). Reports have indicated that an individual can become intoxicated simply by touching the drug.

The Addiction Resource Center conducts approximately 1,600 assessments per year. Studies have shown that ½ of first-time offenders will become second-time offenders and, one-third of second-time offenders will become third-time offenders.
