Dunn called the meeting to order at 12:13 p.m.

Approve Minutes from April 2, 2019 Meeting

Motion: Mueller moved, second by Eiring, to approve the minutes from the April 2, 2019 CJCC Anti-Human Trafficking Ad Hoc Committee. Motion passed unanimously.

Update on Recent Anti-Human Trafficking Task Force Meeting

Dunn reported that the Steering Committee is circulating a draft regarding the roles and responsibilities of the Steering Committee and providing guidance for the workgroups.

Eric Calvino reported that, to date, there have been 6 trafficking cases reported to Waukesha County Child Protective Services in 2019, and 15 total trafficking cases reported between April 2018 and April 2019. Pupp added that any suspected cases have to be reported, validated or not.

Continue Discussion on Committee Goals

Dunn distributed and reviewed a document titled "Waukesha County Anti-Human Trafficking Task Force: Strategic Action Plan."

Carter arrived at 12:22 p.m.

Dunn suggested the group add time lines for the initiatives. McMahon stated that the committee should wait until there is more information available showing how long similar tasks have taken similar workgroups.

Pupp mentioned that the Prevention Workgroup had applied for a state grant to allow for screening at Lad Lake and implementation of the "Ending the Game" training, where they would train up to 500 people.

The committee agreed that an environmental scan is a high priority initiative, as the scan will direct how the workgroup moves forward. The committee also agreed that the Strategic Action Plan, as presented, was thorough and a good starting point for the committee's work. Dunn will re-distribute it after changes, such as the tentative time lines, have been made.

The committee briefly discussed Human Trafficking Courts, geared toward victims of trafficking who are accused of committing a crime.

McMahon stated that data is needed from municipalities on the number of potential human trafficking-related municipal offenses they see (i.e. Escort without a License).

Dunn will obtain information on the Steering Committee's Anti-Human Trafficking grant to see how that would direct this workgroup.

Other Items for Discussion

There were no other items for discussion.
