Discuss and Consider Ordinance 178-O-061 Amend The Town Of Oconomowoc District Zoning Map Of The Waukesha County Zoning Code For The Town Of Oconomowoc By Conditionally Rezoning Certain Lands Located In Part Of The E ½ Of The SE ¼ Of Section 5, T8N, R17E, Town Of Oconomowoc, From The FLP Farmland Preservation District To The R-1 Residential District (RZ127) Fruth presented that this ordinance will rezone property located at W380 N8856 Mill Street in the Town of Oconomowoc from the FLP Farmland Preservation District to the R-1 Residential District to allow the division of a 5-acre farm consolidation parcel from the parent parcel.

Behrend, Zimmerman and Dunn presented that this ordinance requires the use of parcel identification numbers for the recording of any conveyance of any interest in real estate located in Waukesha County and reorganizes sections of the Waukesha County Code regarding the Register of Deeds from Chapter Three to Chapter Six.

Discuss and Consider Ordinance 178-O-067 Modify The 2023 Budget Of The Department Of Parks And Land Use To Appropriate Additional Expenditure Authority For The Golf Course Fund Brunner presented that this ordinance appropriates \$85,000 in additional expenditure authority and increases charges for services revenues by a corresponding amount for additional costs associated with operating the County's two golf courses in 2023.
