Approve Minutes May 15, 2020

MOTION: Johnson moved, second by Crowley to approve the minutes of May 15. Motion carried 6-0.

Executive Committee Report May 18, 2020 and June 15, 2020

Wolff said the Executive Committee, at their May 18 meeting, defeated three resolutions and approved two appointments and one ordinance. They agreed to extend the contract with Conley Media LLC to May 21, 2021. At the June 15 meeting, they heard a presentation on County Board survey results and the County Board Office Strategic Plan Environmental Scan, approved 19 appointments, and heard a grievance appeal for a previous Waukesha County employee.

Discuss and Consider Ordinance 175-O-023 Authorize The Waukesha County Sheriff's Department To Contract With The Kettle Moraine School District To Provide School Resource Officer Services From 2020-2023

Joost and Gumm discussed this ordinance which authorizes the Sheriff's Department to continue to provide school resource officer services to the Kettle Moraine School District. The contract will require the County to provide one deputy to the school district on student contact days and requested teacher in-service days. In addition, the contract allows for separate charge for summer school should the district request school resource officer coverage.

Kettle Moraine will be charged a per diem rate of \$481.36 that will allow for salary and benefit recovery for the County. The number of days billed to Kettle Moraine can be change based on a

mutual written agreement between the Department and Kettle Moraine. Kettle Moraine is anticipating needing 178 days annually of school resource officer services for a total of \$85,682. Charges will be adjusted annually to reflect the average cost of a deputy.

The 2020 Sheriff’s Department Budget, as presented to the County Board, includes the continuation of the school resource officer contract in the Kettle Moraine School District. The budget also includes all positions necessary for the continuation of this contract. The contract term will be from August 1, 2020 through August 15, 2023.

MOTION: Howard moved, second by Johnson to approve Ordinance 175-O-023. Motion carried 6-0.

Sheriff’s Department Update on Mutual Aid and Technology

Gumm said the Sheriff’s Department is in the process of investigating the cost of implementing body cameras and once the costs are known the County can make a decision if it wants to move forward. He said the department has provided support to neighboring communities during the recent protests. He invited committee members to participate in ride-alongs or enroll in Citizen’s Academy to gain a better understanding of the department and the pressures deputies face.

Discuss and Consider Ordinance 175-O-024 Modify 2020 Non-Departmental Budget to Correct Drug Buy Payments to Municipal Law Enforcement Agencies

Paz and Snow were present to discuss this ordinance which authorizes the transfer of appropriations from the Contingency Fund to cover additional operating expenses related to the drug buy money that had been recovered by the Clerk of Circuit Court on behalf of multiple law enforcement agencies and recognized in the Waukesha County Sheriff’s department budget since 2000. Contingency funds are being requested because this is a one-time payment that was unanticipated in the 2020 budget. This ordinance does not result in a direct levy impact. The amounts due to these local enforcement agencies are as follows:
