Coordinated Entry is an important process through which people experiencing or at risk of experiencing homelessness can access the crisis response system in a streamlined way, have their unique needs assessed, and quickly connect to appropriate housing and other services within the Waukesha community.

Coordinated Entry helps our community prioritize assistance based on vulnerability and risk to ensure people who need assistance the most can receive it in a timely manner.

The members of HAC serve approximately 700-1000 individuals and families each year- providing shelter, housing resources, clothing, mental health, domestic violence, counseling/advocacy, case management, job placement, food services, and utility/rental assistance.

By furthering our understanding of homelessness, we can support our community partners and we are better able to provide the right level of support to move individuals and families towards self-sufficiency and finding permanent and stable housing.
