The 339th meeting of the Waukesha County Community Development Block Grant Board was called to order by Chair, Larry Nelson at 3:02 p.m. on Wednesday, December 12, 2018, in room 355 of the Waukesha County Administration Center located at 515 W. Moreland Blvd. in Waukesha, Wisconsin 53188.

- I. The meeting was called to order by Chairman Larry Nelson at 3:02 p.m. with a quorum of the Board present.
- II. On a motion by Chuck Wood and seconded by Kathleen Novack, the minutes from the November 14, 2018 meeting were unanimously approved.
- III. Kristin Silva let the Board know that the Federal budget hasn't passed yet so we are operating under a continuing resolution. The Annual Plan is complete and will be sent to HUD as soon as they will accept it.
- IV. The financial status report was reviewed. Subgrantees are submitting their invoices to close out 2018.
- V. The Executive Committee of the CDBG Board met on 11/28/18 to evaluate the out-of-cycle application for Bear Development in the amount of \$300,000. The application is to help fund a 72-unit development in the City of Waukesha, 4 units will be rented to residents at or below 30% CMI. The CDBG Executive Committee scored the application an 85 out of a possible 100 and recommended the project for funding.

On a motion by Doug Bartmann and seconded by Joan Francoeur, the Board unanimously approved a 30-year, \$300,000 0% interest loan with no annual payments; however, a balloon payment at the end of the 30 years.

- VI. Some projects have been completed and the remaining funds will be reallocated to the unallocated line item. The Board unanimously approved the following:

 - d) Motion by Doug, seconded by Terry: \$6748 from the 2017 ARCh Parking Lot.
